#### Bits and Pieces from the Heart

#### Carp

My priorities were and still are carp – the following is an update from May 2024 newsletter. From 1990 through 2024 a conservative count of 4756 carp have been removed from Eagle Spring and Lulu Lakes. Since 2009, 42 carp have been tagged and I anticipate two more will be tagged in 2025. Five tagged

carp have been harvested for a total cash payout of \$4,500. Again this year, the first tagged carp will be worth \$1,000 and any other tagged carp will be worth \$500. The cost will be covered by the Eagle Springs Preservation group account (see related article on page 7 - Preservation Group)

Since the dumpster was removed from the public launch (October 2022), I am suggesting (same as last year) if you harvest a carp, bag them to minimize the odor issue and put the bag in your garbage every week. If that doesn't work for you, or you don't live on the lake and you have harvested one or more carp, call Tom Day who will meet you and provide bags and put them in his garbage.

In the past, there have been complaints about noise and lights. Call me immediately and I will attempt to contact the guilty parties and give them a first warning. If this disturbance happens a second time, I will provide identification information (i.e. license plate number) to the sheriff's department for appropriate action.

#### Eurasian Water Milfoil (EWM)

This non native aquatic plant (EWM) now includes a hybrid milfoil (more resistant to 2, 4-D) and Starry Stonewort (which so far does not have any successful control measures that work). A combination of harvesting and chemical treatment continues to be our best control options.

I probably should add water celery (Eel Grass) to the above list. This is a native plant that after going to seed late July into August/September uproots and constitutes the majority of the plant mass referred to as "floaters". If there is aggressive removal of the floaters, there is no need to have the harvester on the lake after October.

#### Ordinances

If we have them, they should be enforced. The Board is in early stages of developing an agreement with the Lulu lake patrol for enforcement action on our lake. With all due respect to everyone involved, the above is not the most preferred solution. Hopefully we will have a contract in place so that patrolling can start the first weekend in May. For an update on this subject, we will utilize e-mails and the website.

#### Dredging



Eagle Spring Lake is very shallow, high PH, and with active Eurasian Water Milfoil growth produces a lot of marl (Mg Ca Co<sub>2</sub>). Marl is not good for water clarity and successful fish spawning. For the most part, we had a successful dredging project in the

springs area. But efforts to build on that project were denied by the DNR. There may be renewed interest and success in removal of sediment spearheaded by Allen Kroll and Tom Tynes expertise in this subject area. See article on page 8. Our shallow water lake needs all the help it can get! And now to the bits and pieces:

- Website –The website needs an updating and the pictures we have are of kids that are now adults. We need your pictures, please submit your pictures to admin@eaglespringlake.us with a little description for us to share on our website.
- Clean Boats/Clean Waters Program –
  Last year we used the program coordinated by
  Waukesha/Washington counties. There was
  less coverage compared to previous years.
  Ideally, we need to "fill in the holes" with local
  people, if possible. This program should start
  the first week in May (weather permitting) and
  end after Labor Day Weekend.
- Lawsuit/Dam Failure Analysis (DFA) -This topic could take up this entire newsletter and more but, I'm hoping to focus on the DFA, Stoney Point Hydrology prepared a DFA and that was submitted to the DNR on December 4, 2024. The DNR has requested changes to the document and separately I have questioned whether certain issues were taken into consideration. I have questioned the three summary bullet points, particularly since a dam stability analysis has not been evaluated and we have already been rated "significant" i.e., able to pass a 500 year flood event. There's some evidence to support our rating could be "low". As you can imagine there's a lot more to this but we're not part of the process.

#### ♦ New Ordinance?

And now – for what may be "the elephant in the room". It's called "Wake Enhancement" or Wake boarding/surfing. Your Board started discussion of this topic at their February meeting. Some lake districts/municipalities have already passed ordinances against this boating practice, but to say the least, the subject is very controversial. If you are asked to vote on this please do your homework.

As I have written, this I could reflect on more but I'll stop now.

There are more "bits and pieces to resolve".

#### Lake Preservation

Consistent with the ESLMD "Best Management Practices", the Board has added Lake Preservation to its monthly meeting agenda to discuss protecting the health of Eagle Spring Lake, but also the quality of the lake water for swimming, fishing and boating. These discussions have presented some interesting potential options, as well as some options for individual property owners that can be implemented immediately to improve the quality of their shoreline.

One option being explored is the use of "muck" reducing tablets. These tablets digest muck and have been used in private lakes and ponds with varied success, in some

cases reducing muck levels up to 2 inches per month, with no impact to surrounding plant or aquatic life. Because Eagle Spring Lake has an outfall to the Mukwonago river, use of these tablets does require a General Use permit. ESLMD will be conducting a controlled experiment using lake specific organic material to determine effectiveness.


Regarding immediate actions that can be taken by property owners, representatives of the Board has had several communications with the WDNR regarding this subject to discuss what is, and isn't allowed. In summary, a property owner can remove up to 2 cubic yards of muck per year using mechanical means, without a permit. This includes using equipment such as trash pumps. Disturbing the lake bed is not allowed so this exemption is not to include making shoreline areas deeper. This activity falls under what the WDNR calls a De Minimis Exemption. For those feeling more ambitious, a riparian owner can manually dredge up to 100 square feet by 1 foot deep of material by hand or with a hand-held device. It's important to note that Eagle Spring Lake has a healthy and extensive population of native plants which not only help keep the lake healthy and provide habitat for fish and other aquatic species, but also help keep advantageous invasive plant species under control. Removal of native plants should be avoided to prevent the introduction or spread of these invasive species. Additional information can be found at https:// dnr.wisconsin.gov/topic/Waterways/dredging. With the weather turning and the boating season nearly upon us, the ESLMD Board is also working on ways to help with cut weeds "floaters" from boat traffic or harvesting and muck disposal for those may take advantage of the above exemptions. These discussions are in their infancy and of course any ideas are welcome.

#### Aquatic Plants, Harvesting, Chemical Treatment

In early August 2024, Pat McGuire noticed a not seen before plant (algae) in Pickeral Bay. Chris Hinz and Lance Matthews identified it as Starry Stonewort (SSW). Amanda Schmitz (Waukesha County AIS Specialist) and Patrick Siwula (DNR) recertified that it was SSW. John Grams escorted Amanda Schmitz around the shorelines of the lake looking for SSW. The four areas with observed SSW are on the far north end of Pickeral Bay, the shoreline leading to the springs, close to exit portion of the ski channel, and eastern side of Wambold/Gagliano Island. A presentation by Amanda and Patrick (see website at http://www.eaglespringlake.us/Data/Sites/3/ media/latest-news/2024/eaglespringais.pptx.pdf) concluded with the Boards opinion that more damage (increasing its growth/spread) could occur by trying to remove the plants. A full scale aquatic plant survey is anticipated for mid to late 2026. Subject to weather conditions, we will be treating Jack's Bay with 2, 4-D and Pickeral Bay with ProcellaCor in mid to late April. At our March meeting the bid was awarded to Schmidt's Aquatic.

The harvester will go in the water approximately mid April. We are considering a program where plants could be picked up from your pier or shoreline if you pile them there and would be available during the week to fork them on the harvester. The logistics of this need to be worked out. Approximately 3 days prior to the chemical treatment (preferably on a Monday or Tuesday), we will post signs at your property (pier or tree).

#### **Eagle Spring Lake Preservation Group**

Some time prior to 1990 the Eagle Spring Lake Preservation Group came into being. Their mission was to raise funds for improvement of water quality in the watershed for all of us and future generations. The group included five still on the lake: Janet and Jeff Prokop, Julie and John Mann and myself, Tom Day.

Also, Arlene Zajdel, Candace and Bob Knueppel, Heather and Nate Cobb and Jackie Crivello (all having moved off the lake) as well as Gil Zajdel, Jeri and Bob Posekany, Frank Ekstein, and Joan and Jim Pasterski who have left us.

The group received donations in excess of \$3,000 and with that "seed" money held a spring "carp



out" day from 1990 thru 2001. The purpose of these carp out days was to raise money and focus attention on the invasive carp in both Eagle Spring Lake and Lake

Lulu. These days were held at the Eagle Spring Lake Pub and public launch. There were raffles, a silent auction, food sales, beverages and game prizes for various carp categories (most caught, largest, smallest, etc....). During those twelve carp outs, 849 carp were removed from the lakes and over \$50,000 was raised.

Following 2001, the group took a break. We were exhausted from our efforts. A less labor-intensive carp control effort was implemented in order to tag carp and offer a cash reward if they were harvested (\$1,000 for the first tagged carp in any given year and \$500 for any other tagged carp in that year). To this date, five tagged carp have been turned in and \$4,500 was paid out. A total of 40 carp were tagged between 2009-2022.

The following is a partial list of where the money went:

- Sediment testing and related costs for the two dredging projects: \$14,600
- Donations to fireworks on Eagle Spring Lake: \$1,400

• Fish stocking: \$8,000

Two lake temperature recorders: \$520

Weevil project in 1998: \$4,790

Watershed study: \$11,609

Protection plan: \$4,000

There remains slightly more than \$7,000 in the Preservation Group account. Continued efforts to control carp and/or updating the watershed nutrient study are being considered.

#### <u>Lake Patrol - Safety #1 Priority</u>

Again this Spring's Newsletter contains a separate page (pages 5 & 6) for the Town ordinance pertaining to regulations on Eagle Spring Lake. You are encouraged to become familiar with the ordinance (particularly Section 12.02) and please advise friends, relatives, and renters using our lake of the "local" regulations. Please observe Ski Channel route - wide turn into channel and "hug" island side to maintain legal distance from pier on main shore.

- ◆ Many times friends or relatives of lake residents are stopped by the Lake Patrol because they're not familiar with the regulations, i.e., slow-no-wake hours-areas, traffic patterns, life preserver/cushion requirements, and that the certificate of registration must be on all motor boats when in operation.
- ◆ The "100 foot rule" also applies to those being towed, i.e., skiers, tubers, etc.
- ◆ A frequent complaint <u>from boaters</u> is operating too fast in the access channel to Lake Lulu.
- ◆ The Lake Patrol will stop you only if they see something that is wrong, for example, an expired boat registration sticker. You generally receive these in March or April. Once stopped they have the right and generally will check for safety violations, etc. The DNR can randomly stop and go through a check.
- ♦ Your attitude may make the difference as to whether you get a warning or a citation (Be cooperative, polite, and honest!).

• Who May Operate/Age Restrictions - It is illegal for a parent or guardian operate a vessel in violation of the requirements below.

A person born before January 1, 1989, is exempt from the safety course requirement. Motorboats (Other than a Personal Watercraft) -

A person younger than 10 years may not operate a motorboat.

A person 10 or 11 years old may operate a motorboat only if accompanied by a parent, a guardian, or a person at least 18 years old who is designated by the parent or guardian and the parent, guardian, or designated adult holds a valid boating safety certificate or was born before January 1, 1989.

## A person 12–15 years old may operate a motorboat only if he or she:

Is accompanied by a parent, a guardian, or a designated adult and the parent, guardian, or

designated adult holds a valid boating safety certificate or was born before January 1, 1989, or has completed a boating safety course that is accepted by the Wisconsin DNR.

A person who was born on or after January 1, 1989, and who is 16 years of age or older may operate a motorboat only if he or she has completed a boating safety course accepted by Wisconsin DNR or is accompanied by another person in the motorboat who is at least 18 years of age and that person holds a valid boating safety certificate or was born before January 1, 1989.

Safety certificate must be carried when operating a motor boat or PWC, <u>no matter</u> what adult, parent, guardian, etc. is aboard the same boat or PWC.

- ◆ To complete your boater safety course online, go to https://www.boat-ed.com/ wisconsin/
- Also of importance, Wisconsin Statutes prohibit launching a boat, boat trailer, or boating equipment if there are any aquatic plants or zebra mussels attached.

Hopefully these brief comments will encourage you to spend a few valuable minutes reviewing the ordinances prior to enjoying a safe summer of recreational activities on our lake.

### Special Fishing Regulations on Eagle Spring and Lulu Lake

*Panfish* Limit 10



(Eagle Spring and Lulu Combined)

#### Largemouth Bass

<u>Protected slot size - Limit 3</u> (Eagle Spring and Lulu Combined)

Protected size - 14" - 18" (release)

Allowable keeping size - minimum up to 14" and over 18" are legal to keep,

but only one of the three can be over 18".

#### Northern Pike

Minimum length of 32" - Limit 1

Northern Pike need to be a minimum of 32" to keep.

#### Ordinances Updated in 2015

In 2015, the following 3 ordinances (15-03, 15-04, & 15-05) have either been amended or added to the Town's Ordinances for our lake.

Ordinance 15-03 was amended and the 3 changes are put in bold print for your convenience (12.02-9, 12.02-10, 12.02-12 & 12.05). Ordinances 15-04 & 15.05 are new and we advise that you read them over in their entirety.

# TOWN OF EAGLE - WAUKESHA COUNTY ORDINANCE NO. 15.03 - AN ORDINANCE TO REPEAL AND RECREATE ORDINANCE 09-02 - AN ORDINANCE TO PROVIDE FOR SAFETY AND WELFARE ON AND AROUND EAGLE SPRING LAKE

The Town Board of the Town of Eagle repeals and recreates Chapter 12 of the Code of Ordinances containing regulations and procedures for enforcement effective on, in and around Eagle Spring Lake:

#### 12.01 STATUTORY PROVISIONS INCORPORATED

State boating laws as found in Secs. 30.50 to 30.71, and 30.99 Statutes, as amended from time to time, are adopted by reference.

#### 12.02 ADDITIONAL REGULATIONS

- No person shall swim more than 100 feet from shore without being accompanied by an escort boat.
- 2. No person shall water ski or surf board from 7:30 p.m. or sunset, whichever is sooner, until 8:30 a.m., the following day.
- No person shall tow more than three persons at one time whether on skis or surf board and not more than three persons at one time shall be towed behind one boat.
- 4. No person shall operate a motorboat or watercraft in excess of slow-no-wake between 7:30 p.m. or sunset, whichever is earlier, and sunrise the following day or 8:30 a.m., whichever is later. "Slow-no-wake" means that speed at which a boat moves as slowly as possible while still maintaining steerage control.
- 5. All piers and rafts shall be marked by red reflectors of not less than 3 inches in diameter placed not more than 3 feet from the outer limits of any pier.
- 6. No person shall tow or be towed behind a motorboat unless the person being towed is wearing a life jacket approved by U.S.C.G.
- 7. Interference with markers prohibited. No person shall, without authority, remove, damage, destroy, moor, or attach any watercraft to any buoy, beacon or marker placed in or on Eagle Spring Lake by the authority of the State of Wisconsin, or the Town of Eagle.
- No person shall throw or deposit any metal cans, glass bottles, wood, paper or other litter or debris in or on Eagle Spring Lake or the surrounding shoreline.
- No person shall operate a motor vehicle, defined as every motorized device weighing in excess of 1,500 lbs., upon icebound Eagle Spring Lake, except for the exclusive purpose of shoreline or lake property maintenance or repair.
- 10. No person shall drive a motorized vehicle, includ-

- ing a snowmobile recklessly or imprudently on the ice
- 11. No person shall operate a motor boat or personal water craft in a clockwise direction around the lake during skiing hours.
- 12. No person shall obstruct the channel or channel access during skiing hours. The channel is the area between **Travers** Island and Tuohy's Resort.
- 13. No person shall operate a motor boat or water craft of any kind with a speed exceeding that which is reasonable and prudent with regard to the conditions. In addition, a maximum speed limit of 50mph has been established for Saturdays, Sundays, and Holidays.

#### 12.03 RISK AND LIABILITY

All traffic on the ice bound waters of the lake shall be at the risk of the traveler as set forth in §30.81(3) Statutes. Nothing in this chapter shall be construed as rendering the enacting authority liable for any accident to those engaged in permitted traffic while this chapter is in effect.

#### 12.04 SPECIFIC AREAS DESIGNATED

The areas shown on the attached map incorporated by reference marked by buoys are designated as areas reserved for that activity at that speed and none other:

Slow-no-wake boating: S Swimming: W Navigation: N In: I

Out: O

#### 12.05 BUOY PLACEMENT

The Lake Management District shall be responsible for placing, maintaining and removing authorized buoys. The buoys shall consist of those shown on the attached map incorporated by reference. **See Buoy Map 2015.** 

#### 12.06 PENALTIES

#### A. STATE BOATING AND WATER SAFETY LAWS.

Wisconsin boating penalties as found in s. 30.80, Wis. Stats., and deposits as established in the Uniform Deposit and Bail Schedule are hereby adopted by reference with all references to fines are amended to forfeitures and all references to imprisonment are deleted.

### B. LOCAL BOATING LAWS. GENERAL PROVISIONS.

Any person violating the provisions of this ordinance which is not an adopted state statute shall be subject to a forfeiture of not less than \$25.00 nor more than \$50.00 for the first offense within a year and not less than \$50 nor more than \$100 for any subsequent violations within the year. Each motor vehicle violation shall carry a forfeiture of a minimum of \$50 to a maximum of \$1,000 plus assessments and costs as allowed by law. Failure to pay the forfeiture shall subject the violator to up to ninety (90) days in the county jail. The violator shall pay, in addition to the forfeiture, court costs, jail assessment and pen-

alty assessments imposed by law. Each day a violation continues shall constitute a separate offense.

#### C. DEPOSITS REQUIRED.

1. For all offenses listed in the Uniform Wisconsin Deposit and Bail Schedule for Conservation, Boating, Snowmobile and ATV Violations, the arresting officer shall require the alleged offender to deposit the amount set forth in the schedule **SCHEDULED DEPOSIT.** 

#### a. NON-SCHEDULED DEPOSIT.

If a deposit schedule has not been established for a specific violation, the arresting officer shall require the alleged offender to deposit the maximum forfeiture permitted by this ordinance plus the penalty assessment, jail assessment fee and court costs, as amended from time to time.

- 2. If you have been issued a Citation by a Town of Eagle Lake Patrol Officer, you have these choices to handle this Citation:
  - A. PAY the fine amount on the Citation. You may mail your payment to the Joint Municipal court System or pay the fine at the Joint Municipal Court System before the Court Date
  - APPEAR in court on the Court Date if you wish a Trial.

**MUST APPEAR** in Court if the Citation is marked "Must Appear". If you do not appear in Court an Arrest Warrant or Driver's License Suspension may be ordered by the Judge.

#### **12.07 ENFORCEMENT**

#### A. ENFORCEMENT PROCEDURE

§§66.14.114, 66.115, 66.119 and 66.12, Wis. Stats. as amended from time to time are adopted and by reference made a part of this Ordinance as if fully set forth herein. Any act required to be performed or prohibited by any statute incorporated by reference is required or prohibited by Ordinance. The Town of Eagle elects to use the citation method of enforcement.

#### **B. ISSUANCE OF CITATIONS**

All sections of this Ordinance shall be enforced by the Lake Patrol Officer or the Town Board's appointed representatives.

#### 12.08 OTHER REMEDIES

Neither this ordinance nor the issuance of a citation shall preclude the Town Board or any Authorized officer from other proceedings.

Enacted this 15th day of April, 2015, on motion of Supervisor Rasmussen, Seconded by Supervisor Malek.

## ORDINANCE NO. <u>15-04</u> AN ORDINANCE THAT PROVIDES FOR DESIGNATING THE ENTIRE EAGLE SPRING LAKE WATER BODY TO BE SLOW-NO-WAKE

The Town Board of the Town of Eagle enacts this ordinance that authorizes the Eagle Spring Lake Management District's Chairperson, or acting Chairperson to temporarily declare the entire water body of Eagle Spring Lake to be a slow-no-wake area using his or her discretion when the following conditions may warrant such action:

- a) Water levels exceed 820.52 feet (9.7 Dam gauge) above Mean Sea Level or go below 820.23 feet (9.4 Dam gauge) above Mean Sea Level using the NGVD-29 datum;
- b) When unusual conditions or threats are present in the Lake, such as storm or disaster debris, which present a hazard to boating and recreational interests;
- c) Or when other temporary situations require Slow-No-Wake provisions to protect the shoreline, water control structures, or lake impoundment; or as needed for safe boating, or to assist in emergency response, or maintenance activities.

This declaration shall take immediate effect upon a notice being posted at the Department of Natural Resources Boat Launch and at the Lake District Private Boat Launch and public posting of the order. This order may be enforced using the standard bond schedule for Slow-No-Wake violations and will remain in effect until rescinded by the Chairperson or Acting Chairperson of the Lake District or by majority vote of the Lake District Board.

This ordinance will be published as required.

Enacted this 15<sup>th</sup> day of April, 2015, on motion of Supervisor Davis, Seconded by Supervisor Rasmussen.

## ORDINANCE NO. <u>15-05</u> AN ORDINANCE TO REQUIRE A REVERSE MOTOR ACTION BY BOAT OPERATORS WHEN THEY ENTER THE CHANNEL GOING SOUTH TO LULU LAKE

The Town Board of the Town of Eagle enacts this ordinance that requires a boat operator to reverse their motor at the posted sign entering the channel going to Lulu Lake for a sufficient amount of time to ensure that aquatic plants are removed from the propeller before proceeding further.

The penalty for noncompliance will result in a citation of \$75.00 (first offense), \$125.00 (second offense), and \$175.00 for any additional noncompliance.

Enacted this 15<sup>th</sup> day of April, 2015, on motion of Chairman Kwiatkowski , Seconded by Supervisor Davis.
